Foreword

I am delighted to introduce the annual procurement report for National Procurement.

The report covers the year from April 2020 to March 2021 (20/21) and focuses on the work of

National Procurement in supporting our Health and Social Care services. The period of the report has been dominated by the Covid 19 Pandemic and will form the bulk of the report content.

I hope you find this report helpful and that it provides a clear insight to our procurement strategy, our completed and planned activities and some of the great work my team at NSS National Procurement have achieved.

Reporting Period Achievements

- Developed over 300 contracts (£600m) directly supporting Scotland's response to the Covid 19 emergency
- Sourced and shipped just under 1 Billion items of PPE across Health and Social Care in Scotland.
- Created Intensive Care Unit (ICU) surge capacity equivalent to 720 additional beds and consumables
- Equipped and stocked the NHS Louisa Jordan temporary hospital
- Provided equipment, consumables and reagents for Scotland Laboratory testing capacity and community / in-home testing capability
- Co-ordinated supply and distribution of Scotland's Vaccine allocation and distributed associated consumables
- Established long-term warehouse and distribution capacity for Scotland's pandemic stocks.
- Procured a range of digital solutions to support the response to the pandemic and the redesign of Scotland's health services to enable social distancing and remote working.

At this point I'd like to reflect on the incredible effort of our procurement and supply chain teams, not only my amazing team in National Procurement but also our colleagues across our Health Boards. The extent of the tasks and responsibilities undertaken is highlighted in this report. I am sure you will agree herculean in the response to the global pandemic. It has been due to the personal resilience, dedication and commitment of the individuals across our services that these successes have been achieved. I will be forever in awe of that response and am so proud of everyone involved. It has also been great to see so many of our team progress in their careers with National Procurement and we have been able to recruit in new talent to help support our teams and activities.



Report highlights

- The awards supported business growth and new jobs within our communities
- We have created an 'Innovation Highway' for new ideas and solutions to meet our critical service needs and is supporting business growth and an ease of doing business
- Our commercial strategies have ensured SME businesses can access and compete for our business. 65% of new awards in this reporting period were awarded to SMEs.

Good for places and communities

The contract award investments we have made this year have supported 470 new jobs which is a real tangible outcome of our capability to deliver economic and social benefit to our population.



Our creation of a digitally enabled Community Benefits Gateway to link up community needs with our supplier's willingness to help has

already brought support to community projects and will become a major enabler for delivering community outcomes.

- Our investment in new storage and distribution services has created 19wte new full time permanent roles in National Procurement within areas of deprivation.
- Our commitment to build in community benefits into our major contracts is highlighted in the report.

Good for society

- Our work ensured our front line colleagues and carers were able to continue to help the most vulnerable of our citizens.
- The work of our National Procurement teams in the supply of vaccine and consumables to the highly successful Vaccination programme is safeguarding our citizens and enabling our country to recover and is another example of the work of our team delivering for Scotland.
- Having the broad shoulders of NSS to create a Social Care supply chain from scratch with first deliveries within 5 days from the ask supported our care services and carers at home.

1. Introduction

In 2020-2021 the world experienced the worst pandemic in 100 years. This had a huge impact on healthcare around the world and particularly impacted significantly on Scotland's H&SC services. There were extraordinary demands placed on NHS National Procurement to respond to the emergency and therefore the bulk of this year's report will focus on these impacts and our solutions delivered.

This section details the objectives within our <u>strategy</u> and guides the reader in mapping those objectives to the outputs woven through this annual report. NHS National Procurement has taken the opportunity to refresh our procurement strategy which will be in effect from Financial Year 2021/22 through to 2025/26. This report is based on the prevailing strategy during 2020/21 financial year.

In summary the prevailing strategy set out the following key elements:

National Procurement vision

Be the 'go to' Procurement expertise for health and social care, delivering Commercial and Supply Chain Solutions for the people of Scotland which are sustainable, best value and high quality.

National Procurement mission

To deliver sustainable and innovative commercial solutions that have a positive impact on Scotland's patients, citizens and our economy.

National Procurement purpose

To support the health and wealth of Scotland by delivering services and solutions which stimulate equality and economic growth.

To ensure the continuity of supply, providing goods and services where they are needed, when they are needed.

To embrace emerging technologies and digital solutions to create a commercial function fit for the future

To add value in all that we do, creating opportunities to deliver financial and wider economic benefits from our services.

To ensure the positive impact on patients is a key factor in our commercial decision making.

To ensure the highest levels of transparency and controls for the use of the public funds entrusted to us.

This will be delivered in alignment with NSS's 4 strategic objectives:

- Objective 1: Customer at the heart
- Objective 2: Improving the way we do things
- Objective 3: Increase our service impact
- Objective 4: Be a great place to work

2. Our response to the Covid-19 emergency

We operated at the heart of Scotland's Health and Social Care supply chain response to the pandemic. As our emergency response plans were initiated this necessitated the need for most of our staff resource to support this effort in quarters 1 and 2 of the year. As our response and resilience to future waves strengthened resources were able to be redeployed towards our remobilisation and recovery activities. This section presents highlights of the breadth and scale of our response;

From the outset we recognised that this was a challenge that needed a multi-agency response. The following sections will demonstrate the breadth of engagement that was undertaken to align our approaches and ensure we sourced the correct products, services and equipment in the right quantities and at the right time in support of the Health response to the pandemic.

2.1. Securing Emergency Supplies – PPE, Critical Care & Medicines

Early in the Pandemic it became clear that an unprecedented challenge faced us, we knew that this had to become our total focus. The following extract from recent Audit Scotland report provides a succinct summary of the position:





"The challenges presented by Covid-19 are significant and unprecedented. Staff across the public sector have worked hard together, in challenging circumstances, to respond quickly to the pandemic. The global market for personal protective equipment (PPE) was complex and volatile early in the pandemic, as worldwide demand grew rapidly, international supply chains collapsed, and prices increased. The Scottish Government and NHS National Services Scotland (NHS NSS) had to manage the sharp increase in demand for PPE at the start of the pandemic by securing new supply chains and in setting up arrangements for the supply and distribution of PPE to health and social care settings. Work is under way to develop a longer-term approach for the supply and distribution of PPE."

PPE

To support effective planning and to work within the confines of the systems we had available we developed the concept of PPE Product Families – this approach provided us with a range of suitable products to meet a specific need to support our clinical front line staff, supporting resilience and effective supply management. Our core product families for PPE are as follows:

- Gowns Non-Sterile
- Gowns sterile
- Aprons
- Gloves
- Respirator Facemasks FFP3
- Surgical Masks IIR
- Goggles
- Disposable Full Face Visors

Supporting Front Line Staff

As detailed above there is a specific class of facemask known as a respirator which filters out airborne contaminants. Our respirator standard is the FFP3 which due to its seal and construction filters out 98% of airborne contaminants which is best in class protection for NHSS front line staff operating in environments which Aerosol Generating Procedures (AGPs) are performed. In order to achieve this protection level, it is necessary that each respirator product is fitted

to each individual staff member, due to the introduction of new products this meant that testing had the potential to become a significant bottleneck in ensuring staff safety. We worked with the testing industry to commission the necessary and additional test equipment, consumables and additional test resource to support our Health Board colleagues to work through our entire in-scope clinical population ensuring they had the proper protection at all times.





Quality of product was non-negotiable so we engaged with the British Safety Industry Federation and consulted with the Health and Safety Executive to ensure all our products met the stringent standards required for use across our hospital settings. Our sourcing teams utilised a conformance checklist to ensure any products from new sources of supply were fully validated before proceeding. We also worked with colleagues in Scottish Enterprise who visited factories in China to perform the necessary due diligence on process and documentation which provided assurance that international quality standards would be met.

All of the PPE we sourced was fit for use, manufactured in accordance with international standards and held the necessary certification including CE marking and certificate of conformance.

Meeting Our Service Needs

Over the course of the reporting period National Procurement sourced and shipped the following amount of PPE to Health and Social Care across Scotland;

Around 1.1 Billion individual items of PPE

Almost £200 Million in value terms

Longer term approach

We continue to approach this commodity area with the same rigour that we always apply, that is deep market understanding, knowing the key players, researching market trends and working closely with clinical and other subject matter experts to construct a supply strategy to optimise value and reduce supply risk.

We have new Scottish manufacturing within our contractor supply chains now able to supply the majority of PPE items. For example, our supply chain partners in Scotland are now supplying us with FFP3 masks with a 7-year shelf life, much longer than historical norms, forming part of a strategic approach to ensure appropriate PPE is ready should another critical event occur.

Our main PPE Supplier has been working with us to develop an approach to stock management of PPE through rotating stock through other sectors, supporting us in the avoidance of products going obsolete and ensuring they are not going to waste.

ICU Surge Resilience

At the outset of the pandemic, our medical equipment category team working as a key part of a Scottish Government ICU Support and Resilience Group led by senior figures within Scottish Government and NHS Scotland, were responsible for all equipment and consumable procurement, storage and logistics required to create, and supply on an ongoing basis, an increased NHS Scotland Adult ICU bed capacity of 714 beds in comparison to 173 beds pre-covid.



Alongside this work, in collaboration with Health Board clinical, technical and procurement colleagues, we were responsible for providing equipment and consumable surge capacity for high dependency wards along with all other hospital department's impacted by Covid-19. Two consumable stockpiles were created and are stored in one of our newly acquired warehouses alongside the additional equipment stock necessary to maintain surge capacity resilience. As a highly complex operation this activity required close co-ordination between our medical equipment category and logistics teams.

Collaboration is vital to ensure successful delivery of this activity; our medical equipment team, at all times worked in tandem with our Health Board and Scottish Government colleagues including; Scottish Government Health and Social Care Heads, NHS Scotland Chief Executive and performance team, Scottish Government Resilience team, Clinical teams, Medical Physics teams, Scottish Government statisticians and NHS Scotland logistics teams. In addition to the deep complexity, we also had to work to incredibly tight timescales. Achieving the right outcome involved detailed engagement, planning, forecasting against what was always a dynamic and moving backdrop involving interconnected global supply chains that were and continue to be under unprecedented strain.

Along with many colleagues within Scotland, we also worked in close partnership with colleagues from NHS England and UK Department of Health & Social Care (DHSC) as well as leads from both NHS Wales and Northern Ireland.

By Spring 2021, the team had:

- Purchased, stored and managed £39.8M of medical equipment and consumables
- Negotiated with, and purchased from 84 Suppliers
- Sourced 442 separate part numbers, consisting of almost 600,000 items
- Shipped 1271 lines to hospitals and care settings

Medicines

During the early stages of the pandemic, as patient numbers in ICU increased and clinical practice adapted to treat these patients, there was considerable strain put on the medicines supply chain with usage increasing significantly for a number of medicines.

Our Medicines procurement team were required to engage and collaborate with a large number of stakeholders across Scotland e.g. Directors of Pharmacy, Scottish Government, Critical Care, Palliative Care Special Interest Groups and Health Board procurement teams in order to redefine demand profiles, set up data systems to allow monitoring and manage allocations of stock.

This knowledge prepared us for extensive supplier engagement to ensure that the needs of Health Boards were understood and met, whilst at the same time, continuing ongoing engagement with the other home nations due to the nature of the UK medicines supply chain. Another area of medicine supply chain that was significantly affected was the supply of oxygen. The Medicines procurement team collaborated closely with Health Facilities Scotland (a separate division of NSS) to ensure the continued supply of oxygen to hospitals and community sites.

In addition to the management of the acute supply challenges that the pandemic presented, the

team also led on the creation of a national stockpile of critical care and end of life medicines. This involved the purchase of the majority of identified stocks from existing framework agreements as well as linking with the Department of Health and Social Care to source the remainder of NHS Scotland's requirements via UK-led sourcing work streams.

Management of the national stockpile has also allowed us to implement a continual recycling process to ensure that stock is used prior to expiry date and replaced with longer dated stock.

To date more than £1m of stock has been recycled in this way, avoiding the need for destruction.

The pandemic led to a range of changes in prescribing practice to reduce the risk of patient exposure to the virus, for example fast-tracking the implementation of a number of new medicines that enabled patients with certain conditions to receive treatment at home rather than requiring the need to visit a hospital. There was close working with pharmaceutical companies to put in place pricing agreements and manage available supply.

Despite initial capacity constraints within the market due to the pandemic, demand for medicines homecare services also increased due to the drive to reduce the footfall on hospital sites. The Medicines procurement team worked closely with the medicines homecare providers and the Health Board homecare teams to enable access to home delivery of a wider range of medicines, and introduce remote ways of delivering care, including providing nurse training of injectable devices over video call.

2.2. Additional capacity – Equipping and Commissioning the Louisa Jordan Hospital

A hospital needs supplies and equipment to treat patients. Our Equipping Sourcing Team played a key enabling role in the set-up of the NHS Louisa Jordan.

The temporary hospital, built within the Scottish Events Campus (SEC), had an initial capacity to provide 300 beds, with the capability to expand and accommodate 1,036 patients if required, which is about the same number of beds as the Glasgow Royal Infirmary.

Equipping a hospital would usually take 18 months –but in just 20 days the NHS Louisa Jordan was equipped to the same high standard as any NHS Scotland hospital –providing safe, effective and compassionate care. Our Equipping Sourcing Team sourced beds, furniture, critical care equipment, mobile x-rays, CT scanners and more. Overall 253 different items had to be sourced to meet the full requirement, with 19,476 individual pieces of equipment totalling over £8M delivered to the site and placed by the Team.



2.3. Supply chain and logistics

Supplying PPE and Critical care products on such a huge scale requires suitable infrastructure, National Procurement's overall storage and distribution network has significantly expanded during the reporting period to support H&SC services and the wider public sector. The demand to secure bulk supplies of critical supplies and equipment was assessed and demand profiles created, establishing short, medium and long term storage capacity needs. These involved a mix of NHSS leased large scale warehouses and 3rd Party Logistics providers.

Our warehousing capacity has increased to now at a capacity of 375,000 sq. foot over 5 sites. In addition to our existing National Distribution Centre at Canderside near Larkhall our two new leased and operated warehouse of approximately 120,000 sq. foot each are being fully commissioned and integrated into our overall service solutions delivering seamless operational performance. 3rd Party Logistics services provide a flexible balancing capacity to match demand.

During Summer 2020 after a rapid set up, our first additional large scale warehouse came on stream providing a full support level housing over 100million items of PPE, supporting Health and Social Care across Scotland. It is also servicing other critical supply needs including ICU requirements as well as associated machine equipment. An on-site operational control team with full logistical systems operational capability is increasing the speed at which PPE can be despatched as it now stands as a pick and despatch rate of 100,000 items of PPE per hour. 12-metre-high narrow racking is installed throughout the facility, plus 'bendi' fork lift trucks which pick pallets and convey direct to trucks, increasing the speed at which PPE can be dispatched. These new arrangements have already created 19 whole time equivalent high quality NHSS jobs with NSS National Procurement Logistics team as well as additional temporary roles to support immediate demand capacity.

The creation of a national medicines stockpile also required the creation of additional long term storage capacity with the ability to provide a logistics solution to support the continual recycling process. The Medicines team led on the securing of additional capacity for 1000 pallets via a 3rd party provider, whilst ensuring that all controlled storage requirements were met.

Supporting Health Providers across our Communities

At the outset of the Pandemic we needed to move very quickly to support Health Professionals providing services in our communities with sufficient volumes of PPE to maintain services for NHS patients. To provide a sense of scale this support extended across the following community healthcare estate:

- GP Practices (932 practices across Scotland)
- Dental Practices (1059 practices across Scotland)
- Optometry Practices (691 practices across Scotland)
- Community Pharmacy (1252 practices across Scotland)



Prior to the pandemic services to these Primary Care services were limited and had to be created afresh. Using a phased model our first solution was to provide immediate supply through our Health Board procurement and supplies teams. To improve service and reduce supply bottle necks the service quickly transitioned to a direct delivery model to the aforementioned establishments. This service was phased in between August and December 2020 with deliveries being carried out by our contracted logistics partner.

The second part of the solution was to provide an online ordering system for our community health partners, this would give them the control required to manage their PPE requirements directly. We implemented PECOS, our national public sector ordering system across the Primary Care services. This system is well proven and provided the functionality required and was already fully integrated into our stock management system.

From a standing start in January 2021 we have been gradually on boarding our community health partners and estimated by the end of July 2021, all will be able to order via the PECOS system and receive direct delivery, simplifying the ordering of PPE for our colleagues in the community.

2.4. Supporting Social Care

Like Primary care prior to the pandemic there were no direct supply arrangements from National Procurement to any Social Care services or carers. Working with our partners in Scottish Government, Local Government and Social Care providers, within 5 days we created an immediate ability to request urgent supplies via a helpline and then rapidly established a network of 48 social care hubs; in conjunction with the Health & Social Care Partnerships. The hubs were strategically positioned to provide local availability to as much of the local population as possible.

Since April 2019 we have delivered more than 300 million items of PPE to the sector providing the necessary products for care homes, care at home workers, hospices, personal carers and unpaid carers. We established a strategic hub leads network which ensures that we have input from the sector continually developing our service and delivery as guidelines and PPE requirements changed. The hub process is enhanced by an emergency triage call centre service providing seven days a week support for the sector, with an express direct delivery service ensuring that PPE is always available where required.

2.5. Supporting other sectors

In addition to supporting our Social Care system with PPE we also supported other public sector colleagues with critical PPE.

We have provided PPE to 62 unique organisations who provide vital public services across Scotland. This includes almost 6 Million face masks and over 200,000 litres of hand sanitiser. We continue to work positively with other sectors to ensure that valuable PPE is utilised effectively and are actively working with Scottish Government and local authorities to ensure they come to us in the first instance for their future PPE needs to minimise cost and waste across Scotland. We utilise our knowledge, experience and systems to ascertain these demands alongside our Health and Social care needs to effectively apportion our stock across multiple partners without risking our front line commitments.



2.6. Rapid system innovation

Managing a response to a situation as fast moving and all-consuming such as our pandemic response required rapid technology improvement. Core to meeting this challenge is our Technology Services team. The Technology Services team aim is to be the Centre of Expertise for health delivering Digital Procurement solutions that will create a commercial function fit for the future. Our Technology Services team's main focus over the last year has been to provide procurement solutions which support NP's COVID-19 pandemic response. The key programmes of work have been:

- Future PPE Demand Modelling Providing demand forecasting management information and dashboard reporting solutions to NP, Health Board and SG colleagues to ensure the scale of need of PPE and critical ICU equipment and supplies was understood and could be sourced and secured for our front line services and carers.
- Delivery of a stock management solution and service to support the consumables store in the NHS Louisa Jordan hospital
- PECOS for Primary Care Contractors Enabling approx. 4,000 primary care partners (GPs, Dentists, Opticians and Pharmacists) to order their PPE online via Single PECOS
- Procurement of a new National Inventory Management solution The new Inventory management solution will enable NHSS to manage COVID-19 critical consumables (and the broader range of products used across NHSS) effectively, have accurate understanding of consumption levels and clear visibility of the entire supply chain. Tracking higher end consumables and implantable devices to point of use linked to location, clinician and patient. This will lead to improvements in patient care, releasing time to care and safety of our staff. Funding was secured from SG Health Finance Directorate for software, implementation, annual support costs and additional funding for initial allocation of approx. 890 scanner handsets to Health Boards.
- Development of a Business Case for a 'Scan4Safety' type programme across NHS Scotland – Working with SG Chief Medical Officer's Policy Division to develop case for change to adopt common standards and automatic identification and data capture across Scotland to enable improvements in patient safety, clinical productivity and supply chain efficiency.

All of these programmes of work will continue to be delivered in collaboration with colleagues in NSS, Scottish Government and wider Primary Care partners.

Stakeholder Engagement

Working with our NSS Digital and Security (DaS) colleagues and utilising their development platform we created engagement portals to quickly and efficiently manage communications, assessments and reporting, the following examples show what was achieved;

Covid supplies portal – in the early stages of the pandemic we were inundated with supply offers and had to find a way of effectively sorting, differentiating and processing these through automation, we built an online web portal that placed the onus on would be suppliers to detail their offering in an organised manner; this allowed us to effectively scale our response against the thousands of offers that were submitted, sorting out quality standards and offer prices quickly and efficiently and progressing only those that met stringent quality and commercial standards

Information Bureau – in a highly critical and fast moving environment it can be difficult to track the sheer number of information requests we receive from our stakeholders and external interested parties. Deadlines often are vital and information requires to be consistent and be retained for re-use. To help with these challenges we built another platform to manage and sort the information in an easy to retrieve format, this has been well received by our stakeholders and allows us to manage our information much more effectively and consistently, ensuring we provide open, transparent and correct information when needed.

2.7. Supporting the testing solution

One of the critical mechanisms for controlling Covid-19 outbreaks is through testing our population to identify those infected so they can self-isolate and seek medical support if needed and then to trace and contact others who may be at risk of infection and transmission through close contact. In order to implement this a robust and large scale testing infrastructure is required. National Procurement played a major role in building this capacity this through adapting quickly to provide real time procurement solutions for NHSScotland.

At the outset of the pandemic NHS Scotland had two laboratories capable of processing covid19 350 tests per day. Sourcing and supplying the necessary equipment and products through round the clock activity our testing capacity progressively increased to match demand and a little over three months from the start of the pandemic in Scotland we supported an increase in NHSScotland's lab capacity to over 8,500 tests per day with all 14 health boards having the capability to carry out tests for COVID-19 in-house and new dedicated automated equipment procured and installed in the majority of Health Boards –including all of Scotland's island health boards. The sourcing effort included specialist analyser equipment, swab type testing kits, chemicals, trays and a range of other lab consumables. This successful procurement was achieved within the context of a very stretched and competitive global marketplace with every country competing for their share of these specialist and often hard to secure items.

To ensure good supply could be achieved we've worked closely with Scottish Enterprise who connected us with Scottish SME's and internationally accredited Chinese and Korean manufacturers with whom we have subsequently built up strong relationships and secure supply chains delivering quality products.

Our close working relationship with colleagues from the NHSS National Laboratory Programme ensures that we have up-to-date knowledge on testing requirements and new innovations within this field. A quality assurance workstream was established made up of expert stakeholders which quickly accessed potential supply options and facilitated a swift validation process – enabling us to move rapidly to secure supply as consumables became available within the global marketplace.

We supported colleagues in Northern Ireland with a large volume of sample kits for the undertaking of the UK's Siren Study; we've also supported NHS Wales and Jersey and as we stand now our resilient supply chains are supporting tens of thousands of tests per day across Scotland.



2.8. Supporting vaccination delivery

Vaccination is central to how Scotland will exit the pandemic. Vaccines are medicines; the Covid-19 vaccines were sourced at UK level by the UK Government Department for Business, Energy and Industrial Strategy (BEIS) and distribution in Scotland was co-ordinated by the NSS National Procurement Medicines Team. To date, over 7 million Covid-19 vaccine doses have been distributed to locations across Scotland.

Each vaccine has unique handling requirements including storage of the Pfizer vaccine at -60°C to -80°C and there was a need to ensure that we could enable the transportation and storage of this vaccine across Scotland prior to administering into people's arms; the NSS National Procurement Estates and Facilities Team worked to source a range of cold-chain equipment on behalf of Health Boards including fridges, specialist ultra-low temperature freezers and vaccine porters.

There is also a range of support items that are essential to be able to run a vaccination clinic. The National Procurement supply chain team worked with Health Board procurement leads to agree a standard support list for vaccination clinics including; Type IIR masks, gloves, aprons, visors, swabs, hand gels, wipes, cotton wool balls, orange and black waste sacks, pulp trays, bins, gels and surgical tape, we then sourced required items and co-ordinated distribution to Health Boards. We began this work in December 2020 and have shipped on average around 4.4M of these items per month since.

Finally, the National Procurement team managing the national healthcare waste contract worked closely with waste management leads in Health boards to ensure sufficient equipment was available to support the safe storage of waste at vaccination sites and to ensure provision was in place for the collection and disposal of clinical waste produced by vaccination clinics.

2.9. Maintaining services through digital delivery

Digital solutions have been vital to maintaining access to healthcare services; for example Near Me is a free and confidential web-based technology from one of our suppliers that helps health and social care providers offer video consulting to people. Appointments can take place from home or wherever is convenient, via a device for making video calls like a smartphone through an internet connection.

Prior to COVID-19, all Health Boards in Scotland had commenced work to scale up the use of Near Me. This was still in the early stages of implementation and largely focussed on outpatient services. In 2019, there were around 9,000 Near Me consultations held across Scotland. In March 2020, in response to COVID-19, Near Me was identified as beneficial to supporting physical distancing, reducing the spread of infection and helping support access to health and care services.

NSS National Procurement working with Scottish Government Technology Enabled Care (TEC) and NSS Digital and Security (DAS), negotiated an extension to the contract to allow an accelerated rollout of the solution to all services within each NHS Scotland health board.

Since early March 2020, use of Near Me has increased significantly with up to 17,000 Near Me consultations occurring each week across Scotland. Use of Near Me has primarily been in general practice, outpatient services, community services, care homes and the third sector. On the back of this, and in recognition of the multitude of benefits the platform offers e.g. helping waiting times, or accessibility for people who are in some of Scotland's more remote locations, a vision for the Near Me programme has now been developed with the aim to have all health and care consultations provided by Near Me wherever it is clinically appropriate.

2.10. Economic development activity

In light of the collapse of international supply chains and the closure of supply routes across Europe, National Procurement was tasked with securing and maintaining good supply of vital PPE and critical care equipment and consumables. Through National Procurement's work in establishing new and resilient supply, businesses within Scotland responded to the challenge and we were able to focused on developing local manufacturing supply chains that could de-risk our supply chain and provide consistently high quality products. As part of our urgent response for product requirements during the pandemic over £200million of additional business was placed with Scotlish suppliers with a manufacturing and service footprint in Scotland.

Working with Scottish Enterprise and Scottish Government we developed new sources of supply. Before the pandemic, no PPE was manufactured in Scotland, however as of April 2021, 88 per cent of PPE (excluding medical examination gloves), was manufactured in Scotland, often using Scottish raw materials. Medical examination gloves are almost exclusively produced in Malaysia, where there is an established supply chain.

We estimate that around 470 direct jobs have been created in producing PPE in Scotland as a result of our contracting activity with a further 20 jobs created in support of FFP3 face fit testing.

We have established a formal working relationship with Scottish Enterprise to build upon our pandemic work in establishing robust supply chains for PPE manufacture to consider other opportunities for Scottish industry to respond to future needs and provide compelling solutions for NHSS. Relationships like these are vital to identify and target economic recovery and underpin resilience strategies.

Gross Value Added (GVA)

Our economic analysis colleagues in Scottish Enterprise provided us with a review of the impact of our work in the PPE sector late last year against a significant proportion of PPE spend in the period:

"Taking the identified £102.7 million of PPE expenditure and applying the relevant proxies suggested that this additional expenditure has resulted in £66.7 million of additional GVA as well as supporting c1,400 jobs in the Scottish economy."



(Note: these figures estimate the gross additional impact of NSS spend, rather than the net impact. In order to calculate the net impacts, Scottish Enterprise would have to take account of other factors such as deadweight and displacement which it does not currently have the information to do.)

In our refreshed Procurement Strategy from April 2021 to March 2026, will take greater cognisance of supply chain resilience and economic recover. We will build on the lessons learned during our Ciovid19 response and understandably as we are dealing with complex international supply chains this will involve detailed research, engagement, partnering with industry and application of knowledge to drive the necessary supply chain reconfiguration required to meet our objectives and is a multi-year journey.

3. Review of Regulatory Procurement Compliance


Clearly our activity over the reporting period has been driven primarily by our response to the Covid-19 Pandemic, therefore any review needs to take cognisance of the situation our organisation faced.

Our scope of work covers all regulated procurement's with a national aspect and a monetary value of £100K+.

We awarded 267 regulated contracts in the reporting period:

- 220 or 82% of contracts were in response to covid-19
- 47 or 18% of contracts would be considered business as usual contracting activity

Contracting activity in year



Covid-19 being unprecedented in nature resulted in an unprecedented response, our activitresponse can be categorised within the procurement regulations as follows;

Direct award utilising the, 'Negotiation without advert procedure', 'Light Touch Procedure,' Call off from previously awarded framework contract and Modification of a contract during its term. Breakdown as follows;

Total awards based on Negotiation without advert procedure - 169
Total awards based on framework call off - 44
Light Touch Procedure - 1
Modification of contract - 6

The other 47 awards proceeded in line with our forecasted work plan.

With regards to compliance with our strategy, we would assert that our strategy is to award in line with the procurement regulations and with Scottish Procurement policy which all of our awards did. However, due to the huge strain on our resources there were a number of award notices not placed within the 30-day time period specified in the procurement regulations. Following the initial response to the pandemic we re-established our normal processes and issued the appropriate award notices as required.

SPPN 4/2020 Coronavirus (COVID-19): procurement regulations for public bodies provided the clarity required for Contracting Authorities to act within the boundaries of the Procurement Regulations whilst providing the critical supplies and services needed during the covid-19 emergency pandemic period.

4. Sustainable Procurement

The principles of sustainable procurement have been embedded into the NP strategic procurement process and take into account all the requirements of legislative compliance. All procurement contracting strategies consider the implications of sustainability in relation to the procurement under consideration.

By engaging with our staff and customers who are an integral part of our procurement processes, we continue to deliver solutions for the NHS in Scotland which have sustainable procurement at its core.

The results of embedding sustainability throughout our procurement and contract life cycle are delivering real and tangible benefits for NHS Scotland. Some examples of this are detailed below.

4.1. Maintaining Community Benefits

As is well documented elsewhere in this report 2020-2021 was a year like no other, dominated by our pandemic response. We still maintained a commitment to facilitate delivery of Community Benefits within our Frameworks. We included requirements in six of our business as usual regulated contracts as follows;

- Patient Monitors, Anaesthetic Machines and Ventilators
- Decontamination Consumables & Maintenance
- Purchase of Orthopaedic Trauma & Extremity Implants & Consumables



- Purchase of Orthopaedic Spinal & Scoliosis Implants, Consumables & Equipment
- Radiology Reporting Services
- Fresh Butchermeat & Meat Sundries

As these are multi-year frameworks and primarily delivered through direct contracting between Framework suppliers and Health Boards the reporting of delivery of community benefits from these will appear throughout different annual procurement reports. For this year however we can report the following from our Fresh Butchermeat Framework;

Community Activity:

- Butcher supplier buildings and facilities being upgraded using local SME's
- Introduced food waste management strategy to identify and reduce food waste through all levels of our food supply chain
- As part of our supplier development and audit programme we are ensuring our suppliers maintain staff development programmes

Employment:

- All suppliers on framework are Scottish SMEs directly employing staff due to the national NHSS contract
- Apprentice schemes in place in all departments
- Recruitment drives through job fairs and return to work
- Targeted recruitment
- School leavers programme in place
- Staff training programmes in place

Supporting Education, learning, schools:

- Tours of premises including demonstrations on nutritional values as well as information on sustainability and animal welfare.
- Master butchers visit institutions to demonstrate butchery skills including whole animals by cut and special cuts.
- Visit schools and colleges
- SVQ qualifications/ACCA
- Training days on site for NHS Staff
- Presentations on nutritional values, sustainability, animal welfare,
- Presentations about meat and fish at local schools

Economic:

- Buy from local farms and abattoirs
- Member of Quality Meats Scotland and Scotland Food and Drink
- Fully audited and ethically sourced supply chain
- Work with local community to develop new products
- Food for life scheme
- Support local schools
- Support charities and food banks where possible

4.2. Working with Supported Businesses

Supported Businesses are defined as "economic operators whose main aim is the social and professional integration of disabled and disadvantaged persons where at least 30% of the employees are disabled or disadvantaged".

We continue to maintain a high focus on supporting and helping develop business opportunities for Scotland's supported business community, this being a key part of procurement reform, sustainability and driving Scotland's economic and social recovery.

Supported businesses continue to be a crucial area of Scotland's economy in driving employment for disabled and disadvantaged people. Scotlish Government maintain a high focus and priority on supporting these businesses and view public sector procurement as a key driver of this support and development.

In the last 12 months, despite the intensive pressures of covid and recovery, we have continued this work in both sectoral engagement / support and directly creating and delivering contractual business opportunities. The following are significant examples:

Industry support and engagement

Regular engagement with BASE (British Association for Supported Employment) Scottish Chairperson

Attend and present at BASE regional meetings to keep Supported Businesses informed regarding NHSS and latest procurement opportunities

Represent NHSS on the Ministerial led Supported Business Advisory Group (SBAG) which meets quarterly

Continue to offer current, new and prospective SBs advice and support in understanding NHSS procurement opportunities and creating links and points of contact where necessary; this is often one of the most cited issues by SBs as navigating public bodies as huge as the NHSS can be overwhelming for organisations with usually very small staff and resources

Procurement and contracting

National nurses uniform framework was re tendered successfully with the highly successful supported business sub contract with Haven PTS being maintained; this is worth over £1m a year and directly employs a large number of disabled workers

National textiles framework was re tendered successfully with the sub contract for pillows maintained with Haven PTS; this is worth over £100k per year and directly employs 3 disabled workers

National furniture framework continues to operate successfully which includes a lot reserved for supported businesses which is crucial as this is a primary commodity area for SBs in Scotland.




Environmental Impact

As described already in this report, the continual recycling of the national stockpile of critical care and end of life medicines has delivered financial benefits to Scotland through the avoidance of waste associated with the medicines expiring before use. In addition to this financial benefit, there is an environmental benefit through a reduction in manufacturing greenhouse gas emissions. To date this reduction is equivalent to 170 tonnes of carbon dioxide (CO2e).

5. Other notable outcomes

5.1. Innovation



Increase in activity since re-launch of HIAP Q4 2018

Our Innovation Team works closely with the Scottish Governments Chief Science Office in our aim to support industry and Health in accelerating innovative solutions towards adoption in Health and Social Care. We maintain close relationships with key working groups across NHS Scotland as well as other areas of the Public Sector, Academia, Industry, as well as engaging with the UK 4 Nations amongst others.

Our focus is on projects that have clinical demand as these are most likely to succeed and be adopted.

Our online portal for receiving and assessing possible health innovations 'HIAP' (www.hiap-scotland.org) has shown significant and sustained increase since we relaunched it in 2018. It is firmly established as being the key route into NHSS for new ideas.

Over the past 12 months we have received some 146 potential innovative solutions with 19 of these proceeding to next stages i.e. 12 clinical evaluations/trial, 3 possible collaborations, 3 additions to existing Frameworks and 1 Pre Commercial Procurement (PCP) project.

Our team has close working relationships with key partners supporting 21 clinically lead consortiums where health, academia and industry have come together to collaborate on some of our most pressing health challenges such as Waiting times, Diagnostics, Mental Health, Dementia, Cancer, Frailty, Dermatology and Orthopaedics.

Linked to this work the team support the North, East and West Regional Test Bed groups covering 12 Health Board lead projects with a total funded value of £2.46M. These health/industry collaborations target areas such as; reusable PPE, Diabetes, Al applications for Heart Failure and Fracture, Community support, and Psychological Services.

The team are working with Scottish Government, Health Boards and other Public Sectors to create and maintain a pipeline of innovation project activity with Health having identified some 144 clinically led innovation and research projects.

5.2. EU Exit Transition

At 11pm on 31 December 2020, the transition period of the EU Exit process officially came to an end. As a result of our detailed and co-ordinated planning on a national scale any disruptions felt at port entry points due to customs issues did not affect NHS Scotland. We were confident in our planning assumptions and experienced little to none supply disruptions over the remainder of the reporting period.

We maintained our diligence in reviewing



the latest intelligence and working with our stakeholders and suppliers to ensure that we remained in a good position to respond to events if and when they occurred.

To enable effective and efficient communication we implemented a NHSScotland triage portal and the UK level National Supply and Disruption Response (NSDR) system solution which manages and responds to shortages as a result of EU Exit.

Input from Scotland into the NSDR process is managed solely through National Procurement's dedicated team following exhaustion of the NHSScotland triage process.

We act on behalf of our Health boards through this process as they raise any issues through our internal triage process via our EU supplies portal. We additionally support Social Care providers to access the NHSScotland triage portal via the current PPE support call centre (see section 2.5).





5.3. Delivering on opportunities for our people

An important area for us the introduction and advancement of procurement and supply talent, as such we are pleased to report that late last year we initiated our procurement and supply graduate programme, which is being hosted through our NSS Procurement team operational arm. After a wide reaching and rigorous recruitment exercise we have initially employed one graduate on an exciting 2-year development programme which will incorporate; corporate buying at Health Board level, category and commodity management approaches and supply chain and logistics experience, our expectation is that this will be a great success and lay the foundation for many more graduate trainees' to follow this path into an exciting health procurement & supply career.

Allied to this we also have a proud track record in developing entry level talent into successful procurement and supply professionals. Typically, our entry level staff would be recruited into a commodity specialist role who support our procurement leads in all of the activity of procurement and supply i.e. data gathering, cost analysis, supplier meeting minute taking, quotation offers, specification, supporting market analysis, tender development and learning people skills etc.

To illustrate, we currently have twenty-eight commodity managers across our teams; thirteen of these being promoted internally, meaning almost half of our team of commodity managers have been developed through on the job learning and mentoring with associated provision of academic support where required to achieve membership of the Chartered Institute of Procurement and Supply.

As part of our response to the pandemic we brought in an additional 30 staff across our main disciplines of procurement, supply and logistics, this has involved detailed planning and commitment across our teams to identify, shortlist and recruit these new colleagues, to embark on a detailed and wide ranging induction programme and assimilate our new recruits into highly demanding work streams in support of our pandemic activity and recovery activity.
