

e-Mail Migration from @nhs.net

As we continue to highlight, most @nhs.net auto forwarding has now ceased.

What this means is that if we you have not notified us of a new @nhs.scot or local NHS Board e-mail address, then you may not receive your monthly payment statement from November onwards.

Unfortunately, we cannot second guess what your new e-mail address is and we need you to tell us by completing a new mandate which we have revised and uploaded on our website.

For all payment statements, we require each practice to complete a new mandate and e-mail it to us asap so that we can update our records. Many thanks to those of you who have already done this.

Removal of Patient at Patient's Request

Patients can request to remove themselves from the practice as per The National Health Service (General Medical Services Contracts) (Scotland) Regulations 2018 Schedule 6 Part 2.

Patients can do this by contacting the GP Practice or Practitioner Services and confirming their request in writing. If contacted by a patient who wants to do this the GP Practice can confirm this with the patient and inform Practitioner Services. It should be explained to the patient that if they access other NHS services but are not registered with any other practice within the NHS; clinical reports may be sent by hospital systems to the former registered practice.

Practitioner Services will process the request via the GP Practice, or direct if comes from the patient, we will update CHI and write to the patient to confirm this has been actioned.

Patients are able to re-register with an NHS practice at any point in future.

ePharmacy Infrastructure upgrade - advance notice of unavailability

The ePharmacy Infrastructure will undergo a significant upgrade in January 2021, which means the ePharmacy Message Store (EPMS) will be unavailable for the period of an entire weekend.

The work is scheduled from 6pm Friday 22nd January to 7am on Monday 25th January.

Any AMS Prescription and CMS Serial Prescription messages that are created during the weekend will need to be re-transmitted by the practice once the infrastructure is available again. Any prescription cancellations or amendments of a clinical nature that require processing by pharmacies during the weekend must be communicated manually to the pharmacy, as per best practice, as these messages will not be received during the weekend. This is particularly important for serial prescription cancellations of a clinical nature that need to be processed by the pharmacy. As with prescription messages, cancellation and amendment messages should be re-transmitted once the infrastructure is available again. In addition, CMS update request messages will not be transmitted until the infrastructure is available again. This means that the CMS updates processes to retrieve dispensing information and Treatment Summary reports will not run during the period of unavailability but will be operational once the infrastructure is available again.
