



### **GMS Covid Recognition Payment**

Following your submission, Practitioner Services will be carrying out a reconciliation of the data to ensure that what has been submitted is as accurate as possible. Payment will be made on the 31<sup>st</sup> March with the remittance advice being sent to the nominated e-mail address on the form. Should there be any queries when validating the claims Practitioner Services will be in contact to try and amend these so that payment is not delayed. Following the payment there will be an exercise carried out in which the Practitioner Services data will be cross referenced with NHS Board payroll data to again ensure accuracy and that payments are appropriate. In the case of Locums who could not submit through a practice there will be a separate exercise carried out to capture them, at present the nature of this is still under discussion.

#### **GMS Covid-19 Vaccination Claim Form**

Payment in respect of Covid-19 vaccinations should be claimed on the following form in accordance with NHS Circulars PCA(M)(2020)17 Covid-19 Directed Enhanced Service & CMO(2020)33 Covid-19 Vaccination Programme: https://nhsnss.org/services/practitioner/medical/payment-claims-and-pensions/vaccinations/

Completed claims should be e-mailed to our contractor finance services regional office mailboxes – please do not post claims or enclose them in the mail bags. The cut-off date each month is the 13<sup>th</sup> for payment that month.

Whilst the age cohorts have been taken from CHI, we do not have access to lists of patients or their appointment schedules. Practices have been passing patients to us but unfortunately we are not able to assist. ### **Covid Vaccination - Temporary Residents**

Scottish Government, NHS Boards and National Programmes are working to identify a vaccination pathway for Temporary Patients; those registered with GP Practices and those that are not. Once this is confirmed the pathway will be communicated out.

Once the pathway is defined, and if we are asked to support CHI number for TRs, we will confirm the process for allocating these, which will be on a planned basis and not on ad-hoc requests. Until then there is no requirement for these patients to have a CHI number so Practitioner Services will not be creating one 'on request'.
