Geographic Removals – Interpretation of Regulations

Some practices have been concerned that the time limit for removing patients who are out with the practice area was increased from 7 to 30 days which we implemented last year.

This change was implemented following a review of NHS regulations where we feared we had misinterpreted the current regulations.

We have since verified this with the Scottish Government who have confirmed that the timeframe for geographic removals is 30 days.

Paragraph 20 of Schedule 6, Part 2 of The National Health Service (General Medical Services Contracts) (Scotland) Regulations 2018 refers.

Following a lengthy pilot in our Edinburgh office, we are now looking at changing our process once more as our pilot has not been as successful as we would have hoped.

The Edinburgh office will be starting this new process from 1st July 2021 whereby we will reinstate letters to patients using hybrid mail issuing our letters on a weekly basis.

As part of the new process, practices will e-Mail a template letter not required to be signed and no requirement for you also to notify the patient formally.

This should reduce some workload at the practice. Practices in Borders, Lothian, Fife & Forth Valley will be contacted separately.

Covid-19 £500 Payment Update

With regards to the reconciliation for the claims received on time, we are working through the e-Mail amendments notified by practices and should have this completed by the end of May. After this we will redo the analysis to check for duplicates etc., and then issue a revised remittance and arrange for payment / repayment. That should be fully completed in June.

We are working with the Scottish Government and NSS colleagues to finalise a form for locum practitioners who were unable to be included in the practice £500 bonus claims to provide details of eligible service and bank account details to be paid to. The small number of practices who did not submit a claim at all in time can input their staff on this form when it becomes available and we will arrange payment to the practices so they can pass this on to their employees through their payroll or to partners. We anticipate the claim form being available during June with payments hopefully being made in July.

An update from the SPPA: Your Annual Benefit Statement

The SPPA uploads your Annual Benefits Statement (ABS) by 31 August every year to "MyPension" online services this provides you with regular access to your pension information and reduces the impact on the environment.

Previous statements

We also wanted to let you know that the window has now closed for contacting us regarding previous years' ABS or for any requests for estimates if you are an active member – unless you are retiring before 31 August or did not receive a 2020 ABS.

We do this as the information held on your record (provided on an annual basis by your employer) is now in the process of being updated with the new information your employer supplied us and is currently being calculated and reviewed. So we'd ask that you wait until your 2021 ABS is available before submitting any questions that you may have.
