



# Collection of voluntary authorisation for organ or tissue donation

Despite the new GPR form being in place for some time now, we are continuing to see a high number of transactions of a patient's Organ Donation preferences from GP Practices via PARTNERS to CHI and onward to NHS Blood & Transplant (NHSBT).

Please take care when processing registrations or summarising medical records to ensure that you do not send organ donor information that has not been declared to your practice by the patient. This could result in incorrect information being sent to NHSBT which could overwrite the information that the patient has already provided directly to NHSBT.

Please ensure that you are using the latest version of the GPR form which does not capture preferences.

# **Hospital & Clinical Correspondence**

In 2018, we informed practices that **Practitioner Services no longer processes paper hospital letters, reports or correspondence**. However, we have recently noticed that more practices are returning to sending these to us on paper again. If you receive any of these please remember to action as follows:

- 1) If the person has been a patient registered with your GP practice previously and the correspondence is something you would normally add to a patient's record, please scan it in to Docman and export it. This will quickly and electronically go to the current location of the patient's electronic record where it can be imported.
- 2) If the person has been a registered patient with your practice and the correspondence is not to be added to the patient's record (i.e. 1 above) please return it to the originator.
- 3) If the person has never been registered with your practice please return it to the originator, whether the correspondence is clinical or not.


# Important information regarding the upcoming changes to the delivery and collection arrangement to and from the Practitioner Services office in Aberdeen from 3<sup>rd</sup> October 2022.

Please be advised that the records and mail collections and drop off to and from the Practitioner Services office in Aberdeen to GP Practices in Dundee, Perth, Kinross and Raigmore Hospital will be changing effective from 3<sup>rd</sup> October 2022. The service will now be undertaken by City Sprint from this date.

There will be minimal changes to the way the service will be provided in that the arrangement for records and mail collections and drop off is still the same as before.

Please note that the blue/black mail bags will no longer be in use from this date. We will aim to provide you with supplies of the new mail bags for your use from 3<sup>rd</sup> October. Once you have received the new supplies, please return all the blue/black/grey mail bags to our office for safe disposal.

# **Authorisation of GPR Forms**

The Scottish Government has confirmed that a GP Practice authorised signatory is fine for GPRs now as the registration is with a practice and not the GP.

# Item of Service Fees - Vaccinations Claim Form - PCA(M)(2022)07

GP practices delivering those vaccinations formerly provided under the Vaccines & Immunisations and Childhood Immunisations Additional Services will be paid the following fees:

Anthrax = £83 (the course is 4 doses plus annual reinforcing doses at £21)

Cholera (2 dose course) = £32

D.T.P = £32

Hep A (Adult) = £48 | Hep A (Jr) = £42

Hep A + B (3 dose course) (Twinrix Adult) = £72 | Hep A + B (3 dose course) (Twinrix Jr) = £62

MMR (2 dose course) = £38

Meningitis ACWY = £42

Poliomyelitis – £103 (the course is 5 doses)

Rabies (IM) (3 dose course) = £62

Typhoid = £32

The existing Quarterly claim form has been updated but applies only to GP practices delivering those vaccinations as directed by their NHS Board.

All Directed Enhanced Service immunisations will be paid a fee of £10.06 for each individual dose as below: -

Childhood Immunisation Enhanced Service
Influenza & Pneumococcal Temporary Enhanced Service
Meningitis B (Men B) infant vaccination programme
Pertussis immunisation programme for pregnant and post-natal women
Shingles (Herpes Zoster) Immunisation Scheme
