Freedom of Information Reference: FOI-2023-000152 Teleradiology

I refer to your freedom of information request that we received on 27 April 2023. I can advise you that we have now completed the search of our records and can provide you with the following information:

1. Who is your current teleradiology provider? (If multiple, who provides out of hours/ on-call support?)

Under Section 17 of the Freedom of Information Scotland Act (FOISA) an organisation does not require to provide information if it does not hold that information. NHS National Services Scotland (NSS) does not hold this information. NSS does not use any teleradiology providers. We manage a framework for the Heath Boards to access (NP18820 Radiology Reporting), that has multiple providers for the individual board to decide who meets their requirements best. 
