## Annual payment increase 10.1% to be paid from April 2023

The inflationary rate for payments in 2023-24 has been agreed at 10.1%. The rate is set for each financial year based on the rate of CPI for the previous September. See table below for revised payment levels.

#### **UK Infected Blood Inquiry Update**

Many of you will be aware that the Infected Blood Inquiry published a second interim report on compensation before Easter. You can access a copy of the report in the News section on the Inquiry's website at https://www.infectedbloodinquiry.org.uk/. The Scottish Government has said they welcome the Inquiry's interim report and will consider it carefully. As the Inquiry recommends a UK-wide compensation scheme, the Scottish Government expects to work closely with the UK Government to take forward the development of a compensation scheme to build on the £100,000 interim compensation which was paid out last year. Unfortunately, we cannot say at this stage when further details will be available, but we will keep members updated when any information about the scheme is confirmed.

### **NSS Recognising Excellence Awards**



If there are any queries from DWP, HMRC or your local Council in relation to your income from the scheme we have guidance that we can provide. If you have any problems or you are invited to a formal interview then you may wish to call or email SIBSS staff – they can provide you with a letter to confirm the payments you have received from SIBSS and confirm that these payments should be disregarded. If your benefits are stopped, we have a Benefits Advisor that can help. Please contact us for more information.
