Introduction

National Procurement is the Centre of Procurement Expertise for the NHS Scotland (NHSS). We provide commercial, logistics and technology solutions to Scotland's Health and Social Care services. Our national team also provides expert advice and support to our Health Boards (HBs) on procurement matters, working closely with colleagues in HB procurement teams. We manage over £1.5 billion in national contracts and assist NHSS in spending effectively which releases more resources into frontline services and patient care. Our contracts and services provide high quality and best value arrangements for the medicines, medical services / consumables, non-medical supplies and services, food, and equipment used within our hospitals and health services.

Our National Distribution Service (NDS) is Scotland's largest public sector logistics operation. Our logistics team store and deliver products to help keep Scotland's health and social care operating and work collaboratively with our supply chain team who ensure continuity of supply by working with suppliers and health boards.

Our Technology Service team is the focal point for Purchase to Pay (P2P) solutions and supporting national improvement initiatives and ensuring eProcurement requirements are represented at an NHS strategic level.

Foreword and reporting period highlights

Foreword

I am delighted to introduce the annual procurement report for National Procurement. The report covers the year from April 2022 to March 2023 (22/23) and focuses on the work of NSS National Procurement (NP) in supporting our Health and Social Care services.

Currently our health service faces one of the most challenging times in its history as we emerge from the national response to COVID-19 to recovery and remobilisation of our core services while achieving our service commitments and delivery objectives across strategic sourcing, logistics, and technology.

In a year where supply chains have been adversely impacted by cost pressures due to the global inflationary environment we still delivered financial benefits and increased the number of community benefits delivered contributing to the delivery of additional social, economic, and environmental benefits within Scotland's communities.

I hope you find this report helpful and that it provides a clear insight to our procurement strategy, our completed and planned activities and some of the great work my team at NP has achieved.




Reporting period achievements

During this reporting period our teams have continued to support the Covid-19 testing and vaccination programme, PPE and critical care supply pandemic activities whilst transitioning focus onto a return to core activities. We have been able to consolidate the services created in response to the pandemic and recovery and support the remobilisation of our health services whilst renewing our forward plans and building on these foundations for the future.



Working closely with colleagues across NHS Scotland's procurement and clinical teams some notable achievements include:

- We secured over £43 Million in monetary benefits to NHS Scotland through our commercial activity against over £1.5 Billion in spend under our management.
- Building resilience into our supply chain we concluded the operational use of an • additional National Procurement warehouse at our Coddington site in central Scotland.
- A strategic plan has been developed collaboratively with NHS Scotland Procurement Teams that highlights all the key activities to achieve our Net-Zero target by 2035.
- Working with Health Boards and Scottish Government we facilitated our supplier to deliver a new clinical waste facility for NHS Scotland ahead of schedule.
- We increased the number of community benefits delivered contributing to the delivery of additional social, economic, and environmental benefits within Scotland's communities.
- Maintaining our focus on providing resilience in our Pandemic support by delivering • the key products and services required in response to the Covid-19 pandemic. We assisted in the delivery of Scotland's Covid and Flu Vaccination programme, provided logistics and procurement support for Covid-19 testing programme and continued to support Health and Social Care organisations by delivering PPE to NHS Scotland hospitals, Social Care Hubs, and Primary Care practitioners.

- Deliver our contract workplan to identify secured savings and assist in delivered saving for our customers.
- Support NSS in developing as an anchor institution by supporting local supply chains and delivering social value from procuring goods and services as well as being a large-scale employer and maximising our impact on widening access to employment surrounding local communities.
- To support Net Zero ambition and reduce overall NDS carbon footprint.

Ongoing Pandemic Support

During the period we maintained our focus on providing resilience in our Pandemic support by delivering the key products and services required in response to the Covid-19 pandemic. Here are some of our highlights.

Delivery Of PPE

National Procurement continued to support Health and Social Care organisation throughout 22/23 year delivering PPE to NHS Scotland hospitals, Social Care Hubs and Primary Care practitioners including GP and Dental surgeries to ensure PPE resilience. We delivered around 600 million items of PPE in this year and issued our two billionth item in total until conclusion of Social Care order pipeline in March 2023. Supply of PPE to some Primary Care practitioners will continue in next year to support health care services.

Covid-19 Testing

Our Covid-19 Testing team continued to provide logistics and procurement support to the wider public sector and worked collaboratively across the 4 UK nations with representation on Lab Asset Repurposing Group, UK Reagent assay group and managed and co-ordinated supplies across UK.

The team also manage suppliers to secure delivery pipeline for 12 to 26 weeks including resilient stock to be held and played a key operational role in the supply and distribution of Lateral Flow tests, PCR test kits and associated equipment and chemical components to support the ongoing requirement of tests amongst the population with the associated service provision.

Our role in the Covid-19 Vaccination programme

We maintained the supply chain model to store and distribute the different Influenza and COVID-19 vaccines and associated consumables and, with our key supplier, arranged storage and distribution, ordering and delivery.

In addition to the vaccine activity, our medicines procurement and supply team continued to oversee the supply of Covid-19 treatment medicines supporting the care of seriously ill Covid-19 patients with the latest available treatments. This work also entails intense supply planning activity including the demand modelling, allocation of medicines to individual hospitals, distribution of medicines from across the UK from storage to end destination at the scheduled time and to administer data collection processes.





For the Autumn/Winter Vaccination Campaign our vaccination team co-ordinated the acquisition and distribution which contributed to:


Covid-19

Uptake to date has seen 1.8 million covid-19 booster doses which represented an average uptake of 65.2%.

Adult Flu

Uptake to date has seen 1.7 million adult influenza vaccines (as of 27/11) administered which represents an average uptake of 57.8%. (Uptake in over-65s is ~85%).

Manging Supply Chain



Warehouse Operations

Within the year, we concluded the operational use of a second National Procurement warehouse within the Eurocentral Industrial Estate adding the Coddington site to our Titan warehouse. The combined capital investment for this and our other warehouse site based at Eurocentral in central Scotland is £8M. This has increased the storage capacity of NP by over 20,000 pallet spaces. The new capacity enabled NP to support the issue of over 600 million units of PPE within the year to both health and non-health public bodies. In addition, the facilities supported the issue of 550,000 Covid-19 testing kits and 11.5 million units to the national vaccination programme. Future contingency stocks providing a 12-week buffer capacity of PPE and 8 weeks of ICU surge capacity will remain as resilience capacity.

Warehouse Interoperability Project

We continued work on our Warehouse Interoperability project to increase the operational efficiency of the National Distribution Service operation across our three warehousing sites based in central Scotland (Canderside, Titan and Coddington).

This project led on the implementation of the future state design as well as providing leadership, insight and advice which supports work to ensure the following:

- pandemic stock.
- and the interoperability between all facilities.
- storage and pick activities.

The initial phases of the project have been delivered and our Warehouse Service Design Project board signed off Interoperability project to our Operations Team to lead and conclude.

Supply Chain Performance

Resource has been focused on operational activity to minimise any product shortages. Despite an uplift in warehouse throughput activity by over 25%, first-time order line fulfilment levels of above 95% were achieved. Financial pressures continue to impact across National Distribution Service (NDS) catalogue range in addition to on-going global supply chain challenges due to political, economic, and pandemic challenges over several product categories. However, through the activity of the combined NDS and health board operational groups several resilience initiatives, particularly around the use of product alternatives and contract compliance have provided commercial assurance and continuity of supply.

Product heat mapping combined with a full country of origin product profile has been put in place to support activity and manage associated supply chain risks across our catalogue portfolio of over 9,000 products.

The Warehouse Interoperability programme was key in delivering logistics benefits for NDS including a reduction in the storage of bulk pallets at our third-party logistics provider and associated costs, reducing overall number of bulk pallets across our warehouses and a reduction in labour costs associated with the processing goods in



Clinical Waste

In the summer of 2021 processing of NHS Scotland healthcare waste was severely impacted by a fire at our contractor's waste processing facility. It caused severe damage to the building, plant, and some equipment. Working closely with our supplier business continuity plans ensured effective services were maintained across all NHS Scotland sites.

During the year of this report, operations stabilised resulting in very strong service delivery over the year. Our contractor's new site, based in Glasgow, commenced commissioning in January 2023 and became fully operational in March 2023, ahead of initial target.

This will enable completion and delivery of NHS Scotland's ten-year contract, providing the platform for achieving future ambitions for sustainable healthcare waste processing. This new facility serving NHSS also provides good quality, long term employment.

We are a great place to work!

The public sector, including health services, are facing a challenge of increasing demand against a backdrop of increased economic pressure. Public procurement in Scotland is changing, with savings now expected as business as usual, and with an emphasis on providing innovative products and services to support the nation, the economy, and the environment. Due to these challenges and changes, it has been recognised that NP needs to develop a suitable future strategy to support this.

To assist Health Boards in Scotland to achieve a financially sustainable position we plan to reprioritise and redesign the way we deliver our services to be more efficient, embrace new technology and focus attention on essential services our health services require.



Next Generation

During this year we initiated our Next Generation Procurement programme. This focuses on the ability to develop and create the future of procurement strategies, technologies, and skills to help health and social care services respond to the post Covid-19 landscape and continue to help deliver a sustainable health service.

An initial stage of service and key stakeholder engagement together with an academic research phase was undertaken to help identify the main priorities our services need us to deliver on as well as new and emergent trends in procurement.

Our People Development

Training

We continue to add to and update to our NHSS procurement wide TEAMS training channel and have increased membership to 150 active users. Highlights of training delivered this year are:

- Supply Chain Resilience in our Procurement Toolkit training.
- Additional training on our Social Value & Sustainability responsibility.
- Medical Device Regulations.

Staff

We continue to support and develop our staff and provide them with scope for professional development and continued learning.

We have a programme to support Sourcing and Logistics Supply Chain colleagues to work towards a professional qualification with the Chartered Institute of Procurement and Supply (CIPS). CIPS is the recognised body which National Procurement has selected to use to ensure staff are appropriately trained.

In terms of CIPS Qualifications, we currently have:

- 25 staff that have a qualification.
- 5 currently studying towards achieving a qualification.
- 35 who have indicated they would like to study toward this.

We have Graduate Trainee and Modern Graduate Apprenticeship programmes underway to help us to create compelling entry points in our National Procurement workforce. We have plans for continued development of our existing staff and their skills to meet our future needs. We have provided extensive support for Logistics staff to encourage learning throughout the year.

Many of our staff continue to work from home and we been encouraging our staff to support each other and make use of the resources available through the wider organisation to support their wellbeing.



Further highlights

Innovation

Innovation is essential to NHS Scotland being a leading healthcare service. Our procurement teams provide a conduit for new ideas and inventions in NHS Scotland and fast track proven cutting-edge technologies to deliver improved patient outcomes.

National Procurement supports the work of the Scottish Health Innovation Partnership, part of the Chief Scientist Office (CSO) which aims to strengthen Scotland's innovation activities in health and social care. This work is focused on early-stage innovation and research and development. Specifically running competitions to identify new ideas and allow NHS Scotland to help develop them to a market ready state.

In the last year, our team has initiated 8 new Pre-Commercial Procurements to award research and development contracts to address challenges in the areas of ophthalmology, women & children, diabetes HbA1c monitoring, drug overdose detection response and intervention, medicines and dementia and mental health.

NSS is also a collaborative partner supporting the Accelerated National Innovation Adoption (ANIA) Pathway, led by The Centre for Sustainable Delivery (CfSD), an exciting new initiative focused on fast-tracking the adoption of proven technological innovations across NHS Scotland. The first two projects endorsed are progressing towards formal procurement, one of which will focus on a digital solution to enable faster diagnosis and reduction of waiting times for critical services and the other focuses on devices which enable improvements in self-management of long-term conditions.

The new Scotland Innovates service, launched in Autumn 2022, provides an easy to use, secure route to connect supplier's new ideas with the Scottish Public Sector and NHS Scotland. Scotland Innovates provides a landing zone for current and potential suppliers looking to promote new ideas for innovative products or services. As part of the assessment function, it provides strong links to key stakeholder groups, Innovation Leads and Scottish Government Chief Science Office and Economy Directorate. The new wider scope service provides potential suppliers with information on innovation and development of products and technologies, while advertising useful opportunities such as innovation challenges for industry and academia, and funding routes to assist innovators to be assessed for the Scottish public sector.

The service builds on the success of the NHS National Services Scotland Health Innovation Assessment Portal (HIAP), expanding the submission and assessment of innovative products and solutions across the entire Scottish Public Sector. Developed as part of a collaborative project between Scottish Government Scottish Procurement and Property Directorate (SPPD) and National Services Scotland (NSS), the service works together with representatives from Scotland's other public procurement sectors of expertise. This year, for Health, there were 71 submissions, 32% from Scottish companies, whilst 54% came from English companies and the remainder from outside the UK.





Improving Inventory Management

A new Inventory Management System (IMS) to improve understanding of stockholding, consumption levels and to provide visibility across the supply chain in NHS Scotland has now been implemented in 15 health boards by our Technology Services team.

To improve efficiency, IMS has been integrated with our Purchase to Pay system (PECOS), catalogue content management system (PCCM) and Finance System (eFinancials). The COVID-19 pandemic highlighted challenges with stock management and visibility of products within the supply chain. Funding was secured from Scottish Government Health Finance Directorate to support improved inventory management across NHS Scotland.

Phase 1 of the Genesis Inventory Management rollout is now complete providing, for the first time, stock visibility and transactional ordering data across NHS Scotland at a local and national level.

Key Highlights:

- 15 Health Boards / 40 Hospital sites now live. •
- Over 2,000 Individual departments have generated orders. •
- 760 Live system users registered. •
- £100Million of order value raised on system. •

IMS is a key element of the Scan for Safety Programme which will deliver improvements in patient care through the traceability of medical devices and equipment.

Focus will now move onto the rollout of Point of Care scanning. This will enable NHS Scotland to have the ability to electronically trace approximately 75% of Class III and IIb implantable medical devices in acute settings to patients by March 2026.

Point of Care scanning will initially be rolled out across three pilot sites from Spring 2023.

Whistleblowing

All NHS organisations and service providers in Scotland are required to follow the National Whistleblowing Principles and Standards. The Principles and Standards explain what is expected of NHS organisations and contractors about their handling of whistleblowing concerns.

National Procurement sought responses from all suppliers on in-scope national contracts to confirm they had a Whistleblowing policy on a "once for Scotland basis" to reduce the workload and reporting for NHS Scotland Procurement departments and providing a single point of contact for our suppliers.

Of all suppliers contacted over 90% confirmed they had a policy in place with others working towards developing a policy.

Humanitarian Aid

National Procurement donated over 700,000 FFP3 Respirator Facemasks to the Charity Kids OR, a charity National Services Scotland and Scottish Government partnered with to support hospitals in Africa. These were sent primarily to the Scottish Government's partner countries. FFP3 masks provide the highest level or protection against air pollution.

Review of Regulatory Procurement Compliance

The focus across National Procurement Category teams as we emerged from the pandemic period was to re-allocate staff to support priority activity and ensure continuity of critical supply to health boards. This resulted in a continuous review of FY2022/23 workplan with 58 contracts being deferred to next year's workplan utilising the regulations to extend existing framework agreements beyond original contractual term

The effect of deferring multiple projects to future years has an impact to the contracting workplan over next five years. Detailed analysis of this has been carried out to reprioritise and validate the contract activity and smooth the forward plan to a manageable level in line with available resource.

Contracting Activity in Year

Our scope of work covers all regulated procurements with a national aspect and a monetary value of £100K+.

We awarded 71 regulated contracts in the reporting period:


- 9 or 13% of contracts were in response to Covid-19
- 62 or 87% of contracts would be considered business as usual contracting activity

With regards to compliance with our strategy, we would assert that our strategy is to award in line with the procurement regulations and with Scottish Procurement policy which our awards did.

Commercial leadership for NHS Scotland

One of our core purposes is to provide a service to manage the spend of NHS Scotland on products required to treat our patients where it makes sense to do so. We perform this service in compliance with all public procurement regulations to provide assurance that our business awards are fair and transparent, providing equal treatment to all bidding companies.









We also ensure NHS Scotland receives value for money through competitive business awards delivered through open competition or as we call it, "tendering procedures". Through detailed and robust contracting processes, we ensure we hold all our suppliers to account in meeting their commitments to delivering the range of critical medical products and medicines at the agreed prices. Our tendering and contractual management approach means that we can deliver substantial savings to the public purse in Scotland. The following provides the benefit figures from last year. (Note for explanation of the terms please visit our glossary)


Many supply chains have been adversely impacted by cost

pressures due to the global inflationary environment and there has been a noticeable increase in contract price variation requests from suppliers. Procurement teams put plans in place to minimise and mitigate these where feasible. National Procurement continued to monitor and manage the volatile inflationary environment encountered within this year. Managing price variation requests has had a resource implication taking significant time for our Category Teams to engage and negotiate with suppliers to reduce the impact to NHS Scotland.

Spend under Management

Spend under management is a standard procurement metric. It tells the reader how much of overall organisational 3rd party spend is managed and therefore deemed to be under commercially beneficial terms for the organisation. This could include: lower prices, faster delivery times, dedicated account management, valued customer status meaning that we will be supported in the event of any shortages and be first to benefit from new product and service innovations. These are the main tangible benefits and there are many more intangible benefits that add value to the supplier / customer relationship. Our main way of measuring spend under management is to consult our contract register which is available to view at www.publiccontractsscotland.gov.uk/Search/Search_AuthProfile.aspx?ID=AA11883

The value of our current register is around £1.55Bn.



In total our commercial teams secured £64m in benefits from our spend under management over the reporting period which is a benefit rate of 4% against our spend under management.



In addition to securing new benefits from our commercial and contracting activity we also need to follow through on those "secured" benefits by ensuring these are delivered for Health Board colleagues. The above table represents the value received from previous years' commercial activities with over £35m being delivered. This year's performance reflects positively against National Procurement's benefits delivery where financial secured benefits were £38m and delivered benefits £32m.

Sustainable Procurement Climate Change

Our Sustainable Procurement Steering Group (SPSG) continues to be the focal point and core oversight group for sustainable procurement activities across NHSS Procurement teams. Its purpose is to ensure sustainable procurement activities are communicated, planned, and delivered on an NHSS wide basis. A strategic plan and transformation map has been developed collaboratively with NHS Scotland Procurement Teams that highlights all the key activities to achieve our Net-Zero target by 2035.

National Procurement are collaborating with the other NHS and healthcare partners in England, Wales, and Northern Ireland to align practices and approaches to supplier engagement. We are collating climate change plans from our key suppliers and aim to have plans for all our top 100 suppliers, based on spend.





We engaged with clinical leads across NHS Scotland to remove Desflurane, an anaesthetic gas from use. This gas has a notably higher environmental impact that other gases (2,540 times more than Carbon Dioxide). There is a replacement gas, called Sevoflurane, which in practical terms, is 1/60th of the impact of Desflurane.

Funding has been approved for a Biofuel tank at our National Distribution Centre, resulting in a move towards reducing the carbon footprint of our fleet. We have measured and established a baseline for our transport and delivery services, provided by Menzies Distribution Ltd, our emissions in the period were 1,300 tCO2e. We now will use this figure to measure against future reductions.

Social Outcomes

The Procurement Reform (Scotland) Act 2014 sets out requirements for public procurers in Scotland to achieve the Scottish Government aims to make the best use of public money and assist the government achieve its overarching purpose and strategic objectives.

For any contract (including Frameworks), over £4M consideration is given whether to include a community benefit clause. Increasing community benefit has been a key focus area this year and to further increase the scope to help improve the economic, social, and environmental wellbeing and assist in the reduction of health inequalities across Scotland. A further measure was introduced this year to deliver social value in 90% of all procurement contracts worth over £1m.

Community Benefits

Our work continues in developing the Scotland's Community Benefits Gateway Portal, a free and easy to use online service, connecting NHS Scotland suppliers with third sector community organisations in Scotland who are looking for assistance with a variety of needs.

Community Benefits are tangible, positive outcomes which improve the lives of local people and enable communities to thrive. They are vital for boosting employment and securing the long-term sustainability of communities and increased support for vulnerable people.

This process has been further promoted and embedded with 240 suppliers registered on the portal and an increase in supported community benefits delivered in the year.

Community Benefits in the period

We secured 32 community benefits in the reporting period and present some of these below.

GSK UK Limited

GSK are a key supplier across multiple contracts within our Medicines category and every year run The GSK IMPACT Awards, a national programme that recognises and rewards small and medium sized charities that are doing excellent work to improve people's health and wellbeing in communities across the UK.

At their award ceremony last year one of their winners was Scottish Families Affected by Alcohol and Drugs (SFAD) - supporting anyone concerned about someone else's alcohol or drug use in Scotland. They received a £40,000 donation, plus two places on a free training and development programme.

ARCO Ltd

Arco Ltd one of our key PPE suppliers have been a major contributor of the community benefits scheme and have again supported several projects relating to Children and Young People, Unemployed and the Local community. These include:

A donation of a defibrillator to the Harbourside Men's Shed, located in Irvine, who told us that, as many members are elderly and some of them have heart conditions, they felt reassured having this equipment on site.

Support from Arco staff to Pre-Employability in Clackmannanshire, a project which aims to engage and develop local people and to equip them with the skills they need to confidently apply for jobs and find employment.

Ethypharm

Ethypharm is a supplier across multiple contracts within our Medicines and supported the Scottish Drugs Taskforce work to improve Scotland's response to problem drug use by providing free naloxone kits to a value £10,000 as part of Scottish government Naloxone "saves lives" advertising campaign that. Ethypharm also supported the Scottish Ambulance Service Naloxone programme with resources such as sample kits and information materials.

Abicare Health Solution Limited

Abicare Health Solution Limited who supply medical services provided two wheelchairs to Shopmobility Paisley and District who support people with disabilities and mobility issues by providing hire of mobility equipment. Since receiving the new mobility equipment, the organisation has seen significant additional engagement from the local community.





Fair Work First & The Real Living Wage

Part of our role is to support Scottish Government policy through procurement. A key policy commitment is to implement Fair Work and Payment of the Real Living Wage in the delivery of public contracts where it is relevant and proportionate to do so <u>https://www.gov.scot/publications/fair-work-first-guidance/</u>.

The Fair Work First criteria are incorporated into our tender documents. To emphasise the importance of fair work practices, the following statement was added:

"Those interested in bidding for public contracts are expected to demonstrate a commitment to progressively adopting Fair Work First criteria in their execution of the contract."

This statement serves as a clear directive, underscoring our expectation for suppliers to actively work towards incorporating fair work principles throughout their contract performance. This has been included in over 80% of our regulated procurement exercises.

Our Work with Supported Businesses

Trade Right International

Following the large increase in demand for hand sanitiser and the subsequent worldwide shortage, we committed to large volumes of hand sanitiser. The demand for this reduced significantly resulting in some out-of-date stock. Our PPE Team worked with the Greenock based supported business, Trade Right International who converted the hand sanitiser into screen wash for vehicles as part of their re-cycling programme. This was initially be offered to public sector organisation at a discounted price before being offered to the wider market via our supplier Arco Ltd.

This work created 3 new jobs and secured 4 current jobs that support ex long-term offenders rehabilitate into the community.
