NHS Scotland is comprised of 22 Health Boards (14 territorial Boards and 8 special Boards). The whole estate encompasses some 1 500 buildings, ranging in size and scope from large acute hospitals to rural health centres and small offices. In 2013/14, the annual energy bill for NHS Scotland was c 103M GDP and the estate consumed c 2TWh of energy (equivalent to c 550 000 tCO2e).

NHS National Services Scotland, working on behalf of all the NHS Scotland Boards, is looking to procure a comprehensive environmental data monitoring and reporting system. This system will collate electricity, gas, water and other fuel consumption data from a range of sources (automatic metering, interrogation of central databases, manual entry) and produce bespoke reports and metrics to support ongoing environmental management objectives. The system should also be capable of recording other environmental data, e.g. waste arisings, through manual data entry. The system must have a range of access levels, ranging from single site level through to pan-Scotland data overviews.

The successful supplier will be expected to provide the software solution and associated services to deliver the solution. These will include but are not limited to development, implementation, training, consultancy and support. The system to be supplied should be substantially complete (off-the-shelf) and preferably web-based. The supplier will be required to provide a minimum of five years support. Hosting of the system is likely to be by NHS National Services Scotland however the Contracting Authority would consider a supplier hosted option.
