NHS National Services Scotland (NSS), National Services Division (NSD) does not commission clinical services for patients with Duchenne Muscular Dystrophy (DMD) as these are the responsibility of individual territorial Health Boards (HBs).

NSD does however manage the Scottish Muscle Network (SMN). This is a National Managed Clinical Network for children and adults with neuromuscular disorders, including DMD. The role of SMN is to raise awareness of neuromuscular disorders and to promote the delivery of equitable, high-quality services to all patients with a neuromuscular disorder across Scotland.

You may wish to contact each territorial HB for any information that they hold in relation to your request, as under the terms of Freedom of Information (Scotland) Act, 2002 (FOISA) we are unable to transfer this request on your behalf. At the present time there are no plans for NSS to commission services for DMD.
