Introduction

National Procurement is the Centre of Procurement Expertise for NHSScotland (NHSS). We provide commercial, logistics and technology solutions to Scotland's Health and Social Care services. Our national team also provides expert advice and support to our Health Boards (HBs) on procurement matters, working closely with colleagues in HB procurement teams.


We manage national contracts with an annual value of over £1.44 billion and offer commercial solutions to assist NHSS in spending effectively which releases resources into frontline services and patient care. Our contracts and services provide high quality and best value arrangements for the medicines, medical services / consumables, non-medical supplies and services, food, and equipment used within our hospitals and health services.

Our National Distribution Service (NDS) is Scotland's largest public sector logistics operation. Our logistics team store and deliver products to help keep Scotland's health and social care operating and work collaboratively with our supply chain team who ensure continuity of supply by working with suppliers and health boards.

Our Technology Service team is the focal point for Purchase to Pay (P2P) solutions and supporting national improvement initiatives and ensuring eProcurement requirements are represented at an NHS strategic level.

The Procurement Reform (Scotland) Act 2014 requires all publicly funded organisations with an estimated annual regulated spend of £5 million or more to develop a procurement strategy and to publish an Annual Procurement Report covering the activities in the relevant reporting period of the procurement strategy.

National Procurement publishes an Annual Delivery Plan linked to our procurement strategy to assure we meet our strategic objectives and ensure value for money is achieved. This annual procurement report will set out the performance of National Procurement against the organisational Strategy and summarise the value delivered through procurement activity.





Foreword and reporting highlights

Foreword

I am pleased to be presenting the Annual Procurement Report as a positive record of National Procurement's performance. The report covers the year from April 2023 to March 2024 (FY23/24) and focuses on the work of NSS National Procurement (NP) in supporting our Health and Social Care services.

This report demonstrates that we continue to achieve value for money, deliver against our contract workplan and have improved our service delivery to our customers by improving our processes and enhancing our digital capabilities.

This annual procurement report will set out the performance of National Procurement against the corporate strategy and summarise the value delivered through procurement activity. The report documents performance against agreed objectives and strategic targets including those associated with our social, economic, and environmental benefits.

I hope you find this report helpful and that it provides a clear insight to our procurement strategy, our completed and planned activities and some of the great work my team at NP has achieved.

Reporting highlights

During this reporting period our teams have continued to deliver sustainable and innovative commercial along with supply chain solutions that have a positive impact on Scotland's patients, citizens and our economy.

Working closely with colleagues across NHSScotland's procurement and clinical teams has been key to successful service delivery and some notable achievements include:

- We secured over £30 Million in monetary benefits to NHSScotland through our commercial activity against over £1.44 Billion in spend under our management.
- We performed above target on our National Distribution Service operational performance measures assuring improved product availability and on time deliveries for our customers. Our product availability performance was 97.3% against a target of 97.0% and our on-time delivery performance was 99.7% against a target of 99.6%.
- We increased the number of community benefits delivered contributing to the delivery of additional social, economic, and environmental benefits within Scotland's communities.
- We delivered against our contract workplan identifying secured savings and assisting in delivering benefits for our customers.
- We held our Procurement for Health (P4H) conference that provided an opportunity for over 600 key decision makers from across the healthcare procurement community to meet with our healthcare suppliers.

Looking ahead

I hope you find the content of this report useful, and that it highlights the scope of the activities our NP teams have delivered over the past year. I want to thank everyone in my team for their continued contributions that have meant National Procurement was able to adapt and deliver our key responsibilities and meet our objectives throughout the year. I am very proud of our accomplishments and the way all the procurement teams across NHSScotland have continued to work together, always focused on achieving the end goal of improving patient care.

I am sure we can build upon our continued positive performance as we respond to the evolving needs of our stakeholders by embedding a culture of sustainability and delivering commercial solutions to improve the health and social care services for the people of Scotland.

Our key focus areas are:

- Developing additional commercial opportunities by delivering our contract workplan to identify secured savings and assist in delivered benefits for our customers.
- Providing strategic leadership in digital procurement building on our systems roadmap.
- To develop sustainable procurement strategies to support NHSScotland spend.
- Implement our Supply Chain Efficiency Programme, reviewing current eProcurement systems and processes across NP supply chain to achieve the efficiencies on our stock improvement plans.
- Deliver against our continuous improvement programme to drive ongoing service efficiency by establishing lean quality improvement capability.





Review of regulatory procurement compliance

During the pandemic period we had to defer multiple projects to future years which had an impact to the contracting workplan over the following five years. Detailed analysis was undertaken to reprioritise and validate the contract activity and develop a fully resourced contract workplan in line with available resource with all covid delayed contracts included in our future workplan. The focus across National Procurement Category teams has been to deliver against this contract workplan. Our national contracts are designed to support local economic priorities, enhance social value in communities and support policy delivery.

Contracting activity in an year

Our scope of work covers all regulated procurements with a national aspect and a monetary value of £100K+.

We awarded 112 regulated contracts in the reporting period that have an annual value of £554 million and a full contract term value of £2.7 billion to 413 unique suppliers.

With regards to compliance with our strategy, we would assert that our strategy is to award in line with the procurement regulations and with Scottish Procurement policy which our awards did.

Commercial leadership for NHSScotland

Central to our operating model is the delivery of effective commercial solutions for our customers and service users as well as managing the spend of NHSScotland on products and services required to treat our patients. We perform this service in compliance with all public procurement regulations to provide assurance that our business awards are fair and transparent, providing equal treatment to all bidding companies.

We also ensure NHSScotland receives value for money through competitive business awards delivered through open competition or as we call it, "tendering procedures". Through detailed and robust contracting processes, we work in partnership with our suppliers to assure delivery of critical products, services and medicines at the agreed prices. Our tendering and contractual management approach means that we can deliver substantial savings to the public purse in Scotland.

National Procurement contract owners manage our suppliers to ensure we implement our contracts effectively by developing strategic supplier relationships and assisting our customers in implementing and receiving optimum benefit from our frameworks:


Spend under Management

Spend under management is a standard procurement metric. It tells the reader how much of overall organisational 3rd party spend is managed and therefore deemed to be under commercially beneficial terms for the organisation. This could include: lower prices, faster delivery times, dedicated account management, valued customer status meaning that we will be supported in the event of any supply constraints and be first to benefit from new product and service innovations. Our main way of measuring spend under management is to consult our contract register which is available to view at - https://www.publiccontractsscotland.gov.uk/Search/Search_AuthProfile.aspx?ID=AA11883

The annual value of our current register is around £1.44 billion.


In total our commercial teams secured £30.4m in benefits from our spend under management over the reporting period.

Secured benefits



In addition to securing new benefits from our commercial and contracting activity we ensure delivery of benefits identified in previous years to ensure these are delivered for Health Board colleagues. The table below represents the value received from previous years' commercial activities with over £35m being delivered in the period of report.

Delivered benefits







Many supply chains have been adversely impacted by cost pressures due to global inflationary environment and there has been a noticeable increase in contract prices for goods and services from suppliers. National Procurement continued to monitor and manage the volatile inflationary environment encountered within this year and Procurement teams put plans in place to minimise and mitigate these where feasible. National Procurement teams managed the supplier base to provide an additional £21.5m of secured benefit.

Sustainable Procurement

Climate change

Our Sustainable Procurement Steering Group (SPSG) continues to be the focal point and core oversight group for sustainable procurement activities across NHSS Procurement teams. Its purpose is to ensure sustainable procurement activities are communicated, planned, and delivered on an NHSS wide basis.

Model question

To ensure National Procurement maximise sustainability in our tendering process we trialed an Environmental Model Question this year for intended use in our product based tender evaluations. The approach was trialed over a 7-month period as a mandatory 'information only' question to allow for bidder / buyer interaction and evaluation. A review of this trial is underway and likely to conclude that a directed a bespoke question set linked to the commodity will elicit more a defined response. Development of commodity specific sustainability questions will ensure we embed environmental criteria as part of our procurement processes at all stages, along with working with our suppliers to reduce our environmental impact and ensure we meet our net zero targets. Initial responses from our environmental model question, in addition to a summary review of the trial, will be published to our sustainability website for suppliers to view. A newly developed sustainability consultation process will support the development of inclusive environmental requirements and commodity specific questions in future tenders. The process is designed to maximise cross sector stakeholder engagement through with transparent action and dialogue.

Evergreen


National Procurement has been granted access to information from the NHS England Evergreen Sustainable Supplier Assessment system, a self-assessment and reporting tool for suppliers to share sustainability information.

National Procurement still gather sustainability information through our tendering process, but our longer-term plan is that the responses shared by suppliers through Evergreen will avoid duplication and we can collectively gather Climate Change Plans.

This information is being used to support our own efforts in engaging with our supply base to gather supplier data and has allowed us to develop a reporting tool we share with our customers to track progress with our NHS net zero and sustainability ambitions.

We are ahead of our target of capturing supplier Net Zero Plans from suppliers in our Healthcare category. Our target is to capture 90% of all Healthcare supplier data by March 2025 and we have confirmed Net Zero plans with 86 of our 151 suppliers in this category (57%).

Heat and power purchase agreements (HPAs/PPAs)

To support NHSS plan of being our net zero by 2040 and reducing our carbon footprint by 70% by 2030 we have developed our HPA/PPA category team. The core function of this team is to assist NHSScotland Health Boards in the successful conclusion of Heat and Power Purchase Agreements (HPAs) with the aim of reducing energy costs and carbon emissions.

Under the direction of the NHSScotland Climate Emergency and Sustainability Board an Energy Transition Board (ETB) has been established to lead on the following -

- Managing the Energy Transition Workstream of the National Sustainability Action
- Co-ordinating national support, including funding, to Health Boards for building energy decarbonisation.
- Co-ordinating and overseeing, at a strategic level, a programme of major energy decarbonisation projects for the NHS.

The focus of the ETB is to develop a decarbonisation plan and prioritisation process framework. With the establishment of a Heat and Power Purchase Agreements (HPAs/PPAs) team within NSS National Procurement to support Health Boards with accessing supplies of low-cost renewable energy.





Social outcomes

The Procurement Reform (Scotland) Act 2014 sets out requirements for public procurers in Scotland to achieve the Scotlish Government aims to make the best use of public money and assist the government achieve its overarching purpose and strategic objectives.

For any contract (including Frameworks), over £4M consideration is given whether to include a community benefit clause. Increasing community benefit has been a key focus area this year and to further increase the scope to help improve the economic, social, and environmental wellbeing and assist in the reduction of health inequalities across Scotland. A further measure was introduced to deliver social value in 90% of all procurement contracts worth over £1m.

Community benefits

Our work continues in collaboration with Public Health Scotland to improve the economic, social, and environmental wellbeing of local areas through the Community Benefits Gateway (CBG) Portal, a free and easy to use online service, connecting NHSScotland suppliers with third sector community organisations in Scotland who are looking for assistance with a variety of needs.


Community Benefits are tangible, positive outcomes which improve the lives of local people and enable communities to thrive. They are vital for boosting employment and securing the long-term sustainability of communities and increased support for vulnerable people.

Number of secured benefits by health board

This year the Community Benefits process has been further developed and embedded with the number of suppliers registered on the portal increasing from 245 to 510 and an increase in community benefits secured from 32 to 43.



The map on the left shows the Health Board region the community benefits were secured in across Scotland.

Community benefits in the period

Our suppliers play a lead role through CBG initiatives by:

- Lending much needed safety equipment to families referred to us by their Health
 Visitors or Social Workers to enable them to create a safer home environment in which
 to raise their children.
- Supporting a project to bring Cinema out into the community by providing pop up cinema events in local locations.
- Supporting a pioneering scheme that reduces homelessness by providing young people aged 16 to 25 with the skills and opportunity to refurbish homes and help them into education or employment.
- Providing support for conservation activities to improve greenspaces which encourage people to use them for recreation which can help improve the health of residents.
- Arranging an upgrade of IT equipment to a housing charity.

Fair Work First & The Real Living Wage

Part of our role is to support Scottish Government policy through procurement. A key policy commitment is to implement Fair Work and Payment of the Real Living Wage in the delivery of public contracts where it is relevant and proportionate to do so https://www.gov.scot/publications/fair-work-first-guidance.

It should be noted that the NP scope in application of these policy commitments is limited due to the global nature of our supply chains and the need to maintain fair and equal treatment to all bidders in line with the GPA & WTO rules.



Managing Supply Chain

Our expert logistics services include distribution, supply chain, warehouse operations and fleet management. We performed above target on our key National Distribution Service operational performance measures assuring improved product availability, this is where a product ordered is supplied to our customer, and on-time deliveries for our customers.

Our product availability performance was 97.3% against a target of 97.0% and our on-time delivery performance was 99.7% against a target of 99.6%. We increased revenue from our customers exceeding our target. (£197.27 million vs £184.99 million).

Supply Chain Performance

Resource has been focused on operational activity to minimise any product shortages. Despite an uplift in warehouse throughput activity our product availability levels of above 97% were achieved. Financial pressures continue to impact across National Distribution Service (NDS) catalogue range in addition to on-going global supply chain challenges due to political and economic challenges over several product categories. However, through the activity of the combined NDS and health board operational groups several resilience initiatives, particularly around the use of product alternatives and contract compliance have provided commercial assurance and continuity of supply.

To support NHSS financial sustainability the products held in National Distribution Centre were reviewed to ensure commercial optimisation by transitioning Health Boards to best value products. A catalogue rationalisation programme was initiated to assist in improving warehouse efficiency and remove non-contract products from the catalogue offering.

Our Supply Chain team work closely with our suppliers to revise packaging and product configurations on core product lines to make them safer and easier to handle for our warehouse operations and customers. A few examples of this work have led to annual operational efficiency improvements and delivered sustainable benefits:

- Reduction of 7,500 cardboard boxes by reconfiguring our packaging for waste bags.
- A reconfiguration of our paper pulp products packaging has released 1,600 pallet spaces and will deliver sustainability benefits with 31 fewer trailers being delivered.

Warehouse Operations

We continue to support NHSScotland customers from our three warehouse sites in central Scotland where we stock over 8500 products, supplying circa 80% of the products used every day in our hospitals as well as delivering consumables products to support the Pandemic Influenza Preparedness Programme (PIPP).

We made 13,000 deliveries to our customers and picked and shipped over 4.5 million order lines, a slight increase from the previous year while also reducing emissions from our vehicles by 43 tonnes of CO2 over the year. This reduction was achieved with driver training to improve vehicle efficiency, implementation of eco vehicles and reduction in journeys required due to implementation of new double decker trailers.

We continue to support NHSScotland vaccination and testing programmes and have issued over 6 million units of PPE and have supported the issue of 550,000 Covid-19 testing kits.

Our Health and Safety Approach

Our warehouse teams have developed a programme to ensure they provide a working environment which delivers industry leading health and safety performance while developing an interdependent safety culture.

Our People Development

Training

We have set-up a Professional Development Oversight group to oversee and approve all professional training ensuring a standardised approach and effective use of the available training budget.

Our focus for the year was to support 15 members of staff in attaining professional procurement qualifications from the Chartered Institute of Procurement and Supply CIPS, the recognised body which National Procurement has selected to use to ensure staff are appropriately trained. This significant investment across the procurement team will ensure colleagues have the appropriate skills and experience to carry out their current responsibilities and enable career progression in the organisation.

Our Learning and Development Team has provided comprehensive support to warehouse operations staff through targeted training activities. Sessions have been delivered to ensure all mandatory and statutory training course are complete and compliance levels are maintained. Line managers in our Operations Team have engaged in management development sessions, following the launch of the Management Development Pathways programme and have received guidance on additional professional development opportunities.

Next Generation Programme

During this year we completed the initial phase of our Next Generation Procurement programme. This focuses on the ability to develop and create the future procurement strategies, technologies, and skills to assist health and social care services help deliver a sustainable health service.

In this initial stage we completed a review of our services, identified areas where we could streamline processes so we could release time to focus on procurement activity and considered

how we could develop our Centre of Expertise offering to support our customers.

We are in the process of training our first cohort of staff in Lean Six Sigma Green Belt training to allow the Next Generation programme to enter the next phase of rigorous lean focussed Continuous Improvement and build a foundation to deliver repeatable service improvement.



Further highlights

Procurement for Health (P4H) Event

P4H (Procurement for Health) is a conference that provides an opportunity for the buyer and supplier healthcare procurement community to engage across a range of innovative event features designed to help all participants to explore the initiatives and objectives at the heart of today's healthcare marketplace in Scotland.

The event included:

Product Showcases

For the private sector suppliers, the product showcases provide a unique platform to connect with over 600 key decision makers from across the healthcare procurement community. This provided an opportunity for suppliers to place their products and services in front of key personnel and organisations responsible for setting strategy and the operational delivery of the NHS procurement budget across Scotland.

Skills Development Area

P4H Scotland is free to attend for the public sector and has a Skills Development Area that provides procurement staff to enhance their commercial knowledge through a range of CPD Certified training sessions, all of which are designed to support the development of procurement skills and capabilities.

NHS National Services Scotland Pavilion

The pavilion provides an area where attendees can engage with National Services and Health Board procurement staff directly and can highlight suppliers of opportunities available and inform them of the required routes to be taken to engage in the procurement processes. It also promotes further development of partnerships between suppliers and the NHSScotland procurement community.





Strategic Supplier Management Programme

Our Medical Equipment Team developed a Strategic Supplier Management Programme to ensure benefit was maximised for additional funding provided to modernise NHSScotland's medical equipment inventory.

The key aims of the programme were to:

- Ensure transparency and equal treatment of suppliers.
- Develop and maintain strategic relationships to maximise value and performance.
- Promote NHSScotland as an attractive customer to the global supply base.
- Work with suppliers to procure products in a more sustainable manner.
- Ensure competition in all areas by introducing new competitors where possible and to proactively develop new and emerging suppliers.

Our equipment suppliers were categorised according to risk, spend, opportunity and enthusiasm of working with NHSScotland. The programme was run with close collaboration from NHS service users, technical teams and support functions.

This innovative approach improved our strategic supplier relationship and delivered benefits for NHSScotland:

- Financial benefits in terms of direct price savings, cost avoidance and rebates.
- Competitive pricing compared to the global market.
- Improved access to strategic decision makers staff throughout our supplier base.
- Patients spending fewer days in hospital as a result of the programme allowing early patient discharge due to work with key suppliers.

Supplier Awareness Sessions

To support some of our equipment contract frameworks being awarded our Medical Equipment team have hosted some Framework Launch Event / Supplier Show and Tell Days where all awarded suppliers were invited to show case their equipment and services to all NHS colleagues.

These launch events are aimed at helping NHS clinical, technical and procurement staff to understand the products and functionality of available equipment. They also enhanced market knowledge of the equipment and services and instilled greater competition and understanding as well as developing innovation in the marketplace. Positive feedback was received from NHSScotland delegates and our suppliers.



Medicines Stockpile Recycling

All four nations in the United Kingdom maintain stocks of agreed medicines for pandemic readiness and emergencies. The National Procurement Medicines Team manage the NHSScotland national emergency planning stockpile and have put in place an effective process to minimise waste. When centrally stockpiled medicines are nearing their expiry date and where those medicines are in every-day use by the NHS, they are sold to be used in NHSScotland hospitals.

This approach minimises waste and delivers two key benefits:

- A financial saving to Scottish Government as the income is used to purchase longerdated stock to maintain an in-date stockpile.
- There is a carbon emission saving as there is no requirement for stock to be disposed of.

In recent years, this activity has delivered a financial saving of approximately £2 million per annum and saves 300 tons of CO2 every year.

Innovation

The Innovation team engages and directly supports organisations across Scotland that are driving and funding transformative change, both the creation of disruptive technologies and the subsequent adoption and spread of new innovations.

The team have engaged the market in preliminary consultations and open market competitions aimed at identifying new solutions to solve priority challenges and facilitate R&D in NHSScotland's Regional Innovation Hubs to help develop them to a market ready state.

In the last year, our team has progressed nine Pre-Commercial Procurements through various competition stages which initiate the subsequent feasibility studies and prototype development periods.

NSS is a collaborative partner supporting the Accelerated National Innovation Adoption (ANIA) Pathway, led by The Centre for Sustainable Delivery (CfSD), focused on fast-tracking the adoption of proven technological innovations across NHSScotland.

The first two projects endorsed have completed commercial procurement and are in active adoption of transformation, one of which will focus on a digital solution to enable faster diagnosis and reduction of waiting times for critical services and the other focuses on devices which enable improvements in self-management of long-term conditions.


