The Zapain will come onto framework from the 1st of February. I was wanting to check about how this will be affected by the ongoing co-codamol shortage.

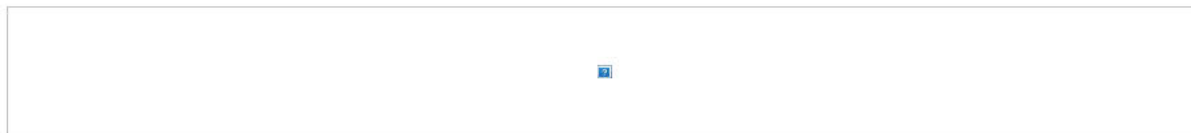
